



VOTING RECORD – 108TH CONGRESS

Vote #1. (Roll Call Vote #115, April 2, 2003) This vote was on a motion by Senator Stevens to kill an amendment being offered by Senator Hollings. The Hollings amendment would have increased funding by \$1 billion for port security, including adding \$840 million for the Customs Service. The Hollings amendment was killed on a 52-47 vote. **NTEU position: NO.**

Vote #2. (Roll Call Vote #176, May 15, 2003) Senator Dorgan offered an amendment to strike from the pending tax bill a provision to allow private collection companies to collect tax debt. Senator Kyl raised an objection to the Dorgan amendment. Before the main Dorgan amendment could be considered, Senator Dorgan had to offer a motion to waive the Budget Act with respect to his amendment. This motion to waive the Budget Act failed and the Dorgan private tax collection amendment ultimately failed. The vote to waive the Budget Act was defeated on a 43-57 vote. **NTEU position: YES.**

Vote #3. (Roll Call Vote #294, July 23, 2003) During consideration of the Homeland Security Appropriations measure, a motion was offered by Senator Cochran to kill an amendment offered by Senator Hollings. The Hollings amendment would have transferred \$300 million in funding from intelligence activities to port security activities. The motion to kill the Hollings amendment was successful on a 50-48 vote. **NTEU position: NO.**

Vote #4. (Roll Call Vote #334, September 10, 2003) Senator Harkin offered an amendment to the Labor-HHS Appropriations measure. The Harkin amendment sought to prohibit the Labor Department from implementing the new overtime regulations proposed by the Bush Administration that seek to strip eligibility for overtime from some workers. The Harkin amendment was adopted by a 54-45 vote. **NTEU position: YES.**

Vote #5. (Roll Call Vote #408, October 23, 2003) Senator Mikulski offered an amendment to the Treasury Appropriations bill that would have prohibited agencies from using any of their funding for the purpose of implementing the Office of Management and Budget's contracting out procedures. The Mikulski amendment was defeated by a vote of 47-48. **NTEU position: YES**

U.S. HOUSE OF REPRESENTATIVES

VOTING RECORD – 108TH CONGRESS

Vote #1. (Roll Call Vote #220, May 22, 2003) This vote was on a motion offered by Representative Cooper to send the Defense Authorization bill back to Committee with instructions to add an “Employee Bill of Rights” for DoD civilian workers. The Cooper Amendment would have made it clear that employees are entitled to full civil service protections including collective bargaining rights. The motion was rejected 204-224. **NTEU position: YES**

Vote #2. (Roll Call Vote #305, June 24, 2003) This vote was on a motion by Representative Rogers to prevent the consideration of an amendment by Representative Obey to increase funding for the Department of Homeland Security by \$1 billion, including additional money to secure ports, borders and airports. The motion passed 222-200. **NTEU position: NO.**

Vote #3. (Roll Call Vote #351, July 10, 2003) This vote was on an amendment by Representative Obey to prevent the Department of Labor from implementing new regulations which would deny the right to overtime pay for millions of private and federal sector workers. The amendment was rejected 210-213. **NTEU position: YES.**

Vote #4. (Roll Call Vote #444, July 25, 2003) This vote was on passage of reauthorization of the Head Start program and included a provision to permit Head Start oversight and monitoring functions currently performed by federal employees to be contracted out. The bill was adopted 217-216. **NTEU position: NO.**

Vote #5. (Roll Call Vote #475, September 4, 2003) This vote was on an amendment by Representative Cooper that would dedicate \$100 million already in the Treasury Appropriations bill specifically for improved compliance activities by the IRS. The amendment failed 192-219. **NTEU position: YES.**

Vote #6. (Roll Call Vote #487, September 9, 2003) This vote was on an amendment by Representative Van Hollen that sought to curtail the Bush Administration’s efforts to contract out government work to private companies. The amendment was adopted 220-198. **NTEU position: YES.**

Vote #7. (Roll Call Vote #624, November 18, 2003) This vote was on an amendment by Representative Obey to instruct House conferees to insist on provisions in the House version of the Medicare Prescription Drug Benefit bill that would allow reimportation of drugs from Canada, keeping costs low for federal and other retirees. The amendment was adopted 237-176. **NTEU position: YES.**
