UNLIMITED ENTRIES

Bitches in season shall not be eligible for entry in any Hunting Test and shall not be allowed on the grounds. Entry fees paid for a bitch withdrawn because of coming in season or for a dog withdrawn because of an injury or illness, or for a dog that dies, shall be refunded in full. A veterinary certificate, received by our Hunting Test Secretary within 5 days of the date of the test, must accompany request for all refunds.

Note: Ribbons will not be mailed unless postage is pre-paid to the Hunting Test Secretary. Do not reduce or enlarge this form. Do not phone, fax, or e-mail entries.

Phones: Cell phones, beepers, and pagers will not be allowed in the gallery nor at the line. These have the potential to significantly disturb the working dog and handler. In the spirit of good sportsmanship, please leave them in your vehicle.
