Board Meeting Highlights

was suggested that the intersection of Shadow Lake Drive and Shadow Ridge be made into a three way stop instead of its present two way stop. The Board is suggesting that homeowners address the Mayor in June regarding this issue. They are also urging everyone to ask the Mayor about the city taking over the sidewalks and light posts. (More on the Mayor's visit in the body of the newsletter)

Sinkhole on Shadow

Lake Drive: It was noted that Dave Piccerillo with the transportation department of the City of Cold Spring is aware of the sinkhole at the top of the hill on Shadow Lake Drive. He thinks it is a settling problem from when the sanitary pipe was installed under the road. He indicated that the council would not agree to dig up the area and put in a patch. However, he did agree to fill the low spot, level out and seal the edges with tar. He noted that it would be noticeable. Should the board opt to have the work done then he will schedule it for sometime

Three Way Stop Sign: It this summer. The Board moved to let the City make the repair. Management also noted that Dave Piccerillo from the City indicated that the dip in the street on Shadow Lake Drive (near entrance of clubhouse) was intended for better drainage. He stated that the street may have settled slightly but does not warrant replacement. Even if the City would agree or repair the street it will only be raised approx 1 inch as the dip/ slope must allow water to flow towards the drains.

> Storm Water Tax: It was noted that the Sanitation District issued a credit of \$1,220.50 that was applied towards the water quantity and adjusted on the Feb 2005

> Building inspections: The Board approved a proposal from Professional Inspectors, Inc to complete a physical inspection of five buildings, on the outsides only. This inspection will include: exterior, roof and two attic spaces. Each building will consist of eight units. Cost is \$1,000 and they will provide a written report. It was noted that two buildings will be selected from Hidden Ridge, one from Misty

Cove, one from Lakewatch and one from Shadow Ridge. Work is scheduled for early May.

Deck Cleaning/Sealing:

Diamond Deck Services was awarded the contract to complete the remaining decks on Shadow Ridge. This will complete the first round of deck cleaning and sealing. Work to be completed in May.

Painting: Hertzenberg and Sons will start this year's painting in mid May. Units to be painted in 2005 are: 200-214, 216-230, 232-246 Misty Cove.

Cluster mailbox housing on Shadow Lake Dr:

Management was asked to obtain a quote to move the cluster boxes from Shadow Lake Drive to Hidden Ridge.

Cluster Mailboxes on

Misty Cove: The Board approved for Rick Brockell to work with GroundMasters to install landscape boulders and plant material to the area on Misty Cove adjacent to the cluster mailboxes.

Board Meeting Highlights (cont'd)

Shepherd's Hooks: The Board unanimously agreed to allow one Shepherd's Hook providing the homeowner submits an architectural application and gets approval from their neighbor, if they share a front entrance. A copy of the adopted rule is enclosed so please add to your handbook.

Drainage behind 500 building:

Management obtained a bid from GroundMasters in the amount of \$4,160 to correct a drainage problem in the rear of this building. The Board requested that management send a copy to the Drees company.

Bluebird Nest Boxes: The Board reviewed an email regarding Mr. Ken Ampfer and his bluebird nest boxes. Mr. Ampfer has installed nest boxes all over the county including Shadow Lake. He is a private citizen who, installs the boxes and keeps them checked. He spends a good deal of time on the project and is only interested in the welfare of the birds. He was unaware that Shadow Lake is a private community. Although he will remove the boxes he requested that the board consider allowing them to stay. He also, requested that should the boxes be allowed to stay could the Board solicit help from homeowners to feed

the birds. After a brief discussion the board unanimously agree. It was noted to solicit help via the newsletter.

Outside Light Fixtures: After noting a difference between the handbook and the declaration regarding outside lights, it was noted that the Declaration over rides the handbook. Therefore, it was suggested to announce in the newsletter that the unit owner is responsible for the repair and replacement of all outside lights.

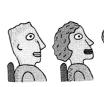

Lake Policy Reminders

- Fishing is permitted from dawn to dusk by residents and their guests.
- A resident owner seventeen years or older must accompany their guest(s) at all times. No one under the age of seventeen (17) will be permitted to fish unless accompanied by an adult owner.
- Fish at your own risk.
- Owners and their guests are responsible for cleaning up after themselves.

- Owners and their guests are to abide by all Fishing and Game Laws including any laws requiring a fishing license.
- No fires are permitted.
- Owners and their guests are to be respectful of the residents at all times.
 No loud music or offensive behavior.

- Fishing from lake banks only.
- No boats are permitted.
- When you catch a fish, please release the fish back into the lake.



Grills, Chimineas & Open Flame Producing Items

No charcoal grills, chiminieas or

any other open flame producing items may be placed on the decks of the buildings. If a resident uses a gas or electric grill on the deck or patio, or a

charcoal grill on the patio, it

must be a minimum of three feet

from the building. All damage caused by any flame-producing device to the common area or to the limited common area is resident responsibility. Repairs, at the resident cost, must be made within thirty days of the oc-

currence or the Association may

enter to make repairs and charge the owner. Repairs are subject to inspection by the Association to assure compliance with the governing standards and regulations. The Association will assume no responsibility for any damage caused by flame producing items.

Front Porch& Stoop: Flowerpots and seating structures for not more than two (2) people may be placed on the front porch or stoop area of a unit. The Association and/or contractors working for the Association will not be responsible for any damage to these items.

<u>Lawn Ornament Policy</u>: Anyone wishing to add anything to the exterior of the unit MUST seek approval by first submitting an Architectural Application.

Signs: For sale signs are to be placed only in mulched areas by the garage. Security signs are limited to one sign in front and one sign in the rear of the unit. The security signs must be placed in the mulch bed in front and next to the unit in the rear so as to not interfere with mowing and landscaping. The Association and/or contractors working for the Association will not be responsible for any damage to these items. No other types of signs are permitted either temporary or permanent with out the proper written consent of the Board of Directors.
