BOARD MEETING HIGHLIGHTS

- **Drees unfinished items:** At the recommendation of attorney Amy Ferguson the Board agreed not to pursue the remaining items left on the original walk through /punch list.
- **Reserve Study:** The Long Term Committee was asked to review the Reserve Study proposal from the Reserve Advisors and make a recommendation as to the need for a study. The Board accepted the Committee's suggestion to do nothing in 2007 but review the need again in 2008.
- **Year- end Financial Information:** Find enclosed financial report for month ending 12/31/06.
- **Speeding / Running Stop Signs: You better watch your speed!** The Cold Spring police are monitoring the community looking for those who speed and run stop signs.

Fireplace Cleaning: It was noted in the January newsletter that homeowners with wood burning fireplaces must have their fireplace chimney cleaned and provide proof to Towne Properties by **5/1/07**. Even if you **do not or have not** used the fireplace it still needs to be inspected. Infrequent use can mean a bird nest , etc. located inside the chimney.

- **Landscape Guidelines:** Summer is rapidly approaching and the time for summer flowers, statues and other patio / yard ornaments. The Board agreed to send out another copy of the **Landscape Guidelines** that were adopted in May 2006. Please take a moment and review these guidelines to make sure you are in compliance with the rules. After **5/1/07** letters will go out to those in violation.
- **Stop Sign – Shadow Ridge:** Tim McCarthy met with the police and the city regarding the stop sign on Shadow Ridge Drive. Once the Police and Safety Committee got involved it was determined that the road needs to have traffic flowing in one direction only. This should take place in the near future.

Do you know the difference?

Common Areas shall mean and refer to the general common elements of the Project and shall include...the land on which the building or buildings stand; the foundation, main walls, roof...the yards, garden and landscaping...recreational facilities, easements, and other facilities available for the common use, in part or in whole, including, but not limited to, the community building, pool, and walking paths; and all other elements of or on the property rationally of common use or necessary to the existence, upkeep, and safety of the Owners and of the Project.

Limited Common Areas or Limited Common Elements means and refers to those Common Areas which are reserved...for the use of a particular Unit or Units, to the exclusion of the other Units. Limited Common Areas are hereby designated to include any parking space or spaces for a particular unit and any balcony or patio attached to a Unit and any heating and or air conditioning equipment servicing a Unit and all other apparatus and installations built or set up to serve only a certain Unit or a certain group of Units. Each Unit Owner shall be entitled to an appurtenant interest in and the exclusive use and possession of those Limited Common Areas, if any, reserved to that Owner's respective Unit or to the group of Units to which that Owner's Unit belongs. **The fee ownership of all Limited Common Areas, however, is vested in all Owners.**

Advertisements:

We hear complaints from residents about ads and circulars that are delivered to homes and become a litter problem. Some homeowners say they don't want them, they are a nuisance, others complain about neighbors who don't clean them up leaving an unsightly collection strewn across the driveway and lawn. To help residents who no longer wish to receive some of these advertisements and publications, here's how to contact the companies who distribute these materials. You will need to ask to have delivery stopped and be prepared to give your name and address. You will only be able to request that service stop at your own residence.

- THE DOOR STORE is delivered on the weekend in plastic bags and contains advertisements including the weekly grocery store ads. If you no longer want to receive the Door Store call them at 513-731-1200.
- THE ENQUIRER/POST DIRECT ADVERTISING is delivered on the weekend in a long, plastic bag and contains advertisements. If you no longer want to receive the Enquirer/Post Direct Advertisements, call their circulation desk at 513-651-4500.
- The CAMPBELL COUNTY RECORDER is a newspaper delivered on Thursday that includes a large amount of news about the area. The Recorder is delivered at no charge but they occasionally include an envelope for voluntary subscription contributions. If the Campbell County Recorder is currently delivered to your home and you no longer want to receive it, contact them at 859-781-4421
